Atlas Copco was formed in 1873 and is a provider of 100% oil-free and high- pressure compressed air. The company's products range from compressed air and gas equipment through to generators, construction and mining equipment, industrial tools and assembly systems. Services include pressure testing and offshore oil and gas pipeline cleaning, with the rental division established in 2006.

Triple certification at Atlas Copco

Businesses relying on oil-free compressed air for their manufacturing processes cannot compromise on the level of air purity, because any contamination could jeopardise the quality or safety of the product. Therefore, triple certification has a fundamental place in supporting the Specialty Rental Division's mission to become the market leader worldwide in oil-free, high pressure and compressed air applications rental, because it demonstrates a commitment to quality in every facet of the business

ISO 9001

As part of the triple certification, the ISO 9001 QMS was also adopted by the division to help improve internal processes and to demonstrate commitment to quality throughout the business.

ISO 14001

One of Atlas Copco's most significant environmental goals is to implement an EMS in all operations to help minimise environmental impacts. In 2007, 44% of Atlas Copco's employees worked in an EMS environment, with the objective to eventually reach 100%. Compliance with ISO 14001 helps the company to achieve this target and ensure that its environmental performance is managed and improved over time. The Group also works constantly to improve the efficient use of resources in the manufacturing process, and has achieved significant reductions in both energy and water use in recent years. As one of the first accredited certification bodies, LRQA is a market leader in the provision of ISO 14001 certification - over half of the

world's top 200 companies choose LRQA for their Business Assurance needs.

OHSAS 18001

Atlas Copco aims to offer a safe and healthy working environment in all its operations and OHSAS 18001 OMS certification provides a robust mechanism to ensure this happens. The Group has a target to reduce the number of accidents to zero and to take actions when appropriate. The OHSAS 18001 standard helps demonstrate diligence and promotes existing OHS within the Group.
